### GENERAL INSTRUCTIONS

1. Eligible candidates are advised to apply online through National Jobs Portal at their link <https://njp.gov.pk>. Candidates applying for more than one post should apply online for each post separately. No manual or hard copy of application will be accepted by any office.
2. The above referred vacancies shall ordinarily be filled on local basis in terms of Rule 16 of Civil Servants (Appointment, Promotion & Transfer) Rules, 1973.
3. Candidates will be required to bring original documents (Educational, Domicile and Experience Certificate etc.) along with one set of attested copies of all documents at the time of Test/interview.
4. Screening / skill tests (where required) will be conducted as per Recruitment Policy of the Federal Government.
5. The Authority reserve the right not to fill any vacancy or to reduce/increase the number of vacancies, if the circumstances so warranted at the time of final selection.
6. The candidates working in Public Sector Departments/Organizations shall apply through proper channel and have to submit Departmental Permission Certificates from the respective department/employers at the time of interview, failing which they will not be allowed to participate in interview.
7. In addition to 5 years general age relaxation already allowed in the above table, further age relaxation shall be admissible as per (Relaxation of Upper Age Limit) Rules, 1993.
8. Minimum and Maximum age shall be calculated on the closing date for receipt of applications.
9. Information provided in the online Application Form will be verified. In case of any false or forged information, NACTA reserves the right to cancel candidature of any candidate at any stage (even after employment, if so revealed later) and to initiate legal action against the applicant.
10. Only short-listed candidates will be called for test/interview. All the candidates will be allowed provisionally to appear in the test/interview, subject to detailed scrutiny of their eligibility as per relevant criteria.
11. **No TA/DA will be admissible for the Test/ Interview.**
